








SIDE VIEW


FRONT VIEW




SIDE VIEW




Electrical Schematic


Primary windings and secondary windings to be connected in parallel on PC board.




Primary windings and secondary windings to be connected in parallel on PC board.



The duration from room temperature (25 °C) to peak temperature is 8 minutes maximum.




